ITEM 5.03 AMENDMENTS TO ARTICLES OF INCORPORATION OR BYLAWS;

Effective December 8, 2004, Pure Cycle amended its Articles of Incorporation to reduce the number of authorized shares of common stock from 250,000,000 shares to forty million (40,000,000) shares.

At a meeting of stockholders held on April 12, 2004, the stockholders authorized the directors to reduce the authorized shares of common stock at any time prior to December 31, 2004. The directors determined to effect the reduction in authorized shares on November 23, 2004.

FIRST: This Certificate of Amendment amends the provisions of the Corporation's Certificate of Incorporation (the "Certificate of Incorporation"). SECOND: The terms and provisions of this Certificate of Amendment have been duly adopted by the Corporation's board of directors and shareholders in accordance with Section 242 of the General Corporation Law of the State of Delaware and shall become effective when filed. THIRD: Article IV of the Certificate of Incorporation is

hereby amended by deleting Section 1 thereof in its entirety and substituting the following in lieu thereof:

Section 1. Authorized Shares. The number of shares of capital stock of all classes which the Corporation shall have authority to issue is sixty-five million (65,000,000) shares, of which forty million (40,000,000) shares shall be of a class designated as common stock, with a par value of one-third of one cent (\$.00333) per share, and twenty-five million (25,000,000) shares shall be of a class designated as Preferred Stock, with a par value of one-tenth of one cent (\$.001) per share.
